Title IX at Dartmouth

Title IX is a federal civil rights law that was passed as part of the Education Amendments of 1972. It states that:

"No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving federal financial assistance."

In other words, Title IX prohibits sexual assault, sexual and gender-based discrimination and harassment, dating and domestic violence, and stalking.

The Office of Equal Opportunity, Accessibility, and Title IX (EOATIX) oversees Title IX at Dartmouth and has a responsibility to promptly respond to incidents of sexual assault, sexual and gender-based harassment and discrimination, dating and domestic violence, and stalking. The EOATIX office also provides campus training and manages sexual misconduct investigations.

Reporting Title IX Concerns: Where to Report

Confidential Resources: Confidential resources **may not share** an individual's information without their expressed consent unless there is imminent danger to self or others, or as otherwise required by law, such as cases involving the sexual abuse of a minor.

Non-Confidential Resources: Non-confidential resources **are required to promptly share** incidents of sexual misconduct, including all known details and identifying information, with the Title IX Coordinator. Information will only be shared on a need-to-know basis and will not be shared publicly.

Reporting Title IX Concerns: What to Expect

The EOATIX office receives a report directly or from a Responsible Employee.

The Title IX Coordinator provides information and resources and proposes a voluntary meeting.

If the complainant agrees to meet, the Title IX Coordinator collects information to understand the nature of the report and discuss supportive measures, processes, and policies.

The Title IX Coordinator conducts an initial assessment to determine if the report falls within the jurisdiction of Title IX and connects impacted individuals with supportive measures.
